- Applicant's Birth Certificate or Singapore Citizenship Certificate
- **Mid-Year** result slips for the year 2019
- NRIC or Singapore Citizenship Certificate of both parents
- Death Certificate (if applicable)
- Divorce / Marriage Certificate (where applicable)
- Parents and / or siblings **latest** pay slip (s) or Notice of Tax assessment

3 **Only Students studying in Primary Schools in 2020 are eligible to apply.**
